# Dear Congregation,

As we enter the fall season, our hearts and minds turn toward two essential themes: *prayer* and *thanksgiving*. From Moses' song of thanksgiving after crossing the Red Sea, to Paul's letters filled with gratitude, we'll be reminded of the transformative power of a thankful heart.

These two months provide a meaningful time to engage in prayer and thanksgiving—two pillars of our faith that can strengthen and uplift us all. Let us come together as a church family, ready to pray, give thanks, and grow deeper in our relationship with God.

# **Catechism Corner: Reflections on the Evangelical Catechism**

- 3. In our seeking the Kingdom of God, in our longing for God's righteousness, and in our hope of inheriting eternal life, what must we do?
- A. We must place our trust and our hope in our Lord Jesus Christ, who is god's mighty claim upon our whole lives. Through him we are delivered from the idols of the world to free, joyous, and grateful service to the whole creation.

In seeking the Kingdom of God, our task is not simply to perform good deeds or follow religious rituals, but to place our full trust in Jesus Christ. He is God's ultimate claim on our lives, calling us

to turn away from the false idols of the world—things like power, wealth, or personal ambition—and toward a life of freedom, joy, and gratitude. Through Christ, we are invited into a new way of living, one that serves and honors the whole of creation. It is through Him, not through our own striving, that we inherit eternal life and live in righteousness.

**Question for Thought:** In a world that often values self-sufficiency and control, how do we truly place our hope in Christ and reject the "idols" of the modern age (e.g., materialism, individualism, or security)? How might this shift impact the way we live, work, and serve others today?

# RETURN OF THE PONY EXPRESS

The financial planning and budgeting drive will again utilize the Pony Express relay system. The relay system is as follows:

- Our church families have been divided so that the homes are in approximately the same neighborhoods. Each route is headed by a Trail Boss.
- A Saddlebag has been prepared for each Route. Each Saddlebag will contain the Route and personal giving cards for each family in an unsealed envelope.
- The Trail Bosses will begin the Run in October or November. They will complete their giving card. Each giving card has 2 sections: 1) the large section of the giving card is placed in the envelope and sealed; 2) the small section of the giving card is to be kept as your reference throughout the year. They will return the sealed envelope to the Saddlebag.
- The Saddlebag is then taken to the first family on the Route. Families on the Route are listed by name, phone number, address and order of delivery. When you move the Saddlebag, call the Trail Boss that the bag has moved. This will allow us to track the progress of the Run. Our goal is to move the Saddlebag every 24 hours. When the last family on the Route has completed their giving card, call the Trail Boss to pick up the Saddlebag.
- The Saddlebags will be taken to the Church office. Our secretaries will open the envelopes, maintaining complete confidentiality as is done with your weekly giving. The Finance committee will be presented with the total of the estimated giving from all cards.

Remember, we are asking for an estimate of giving. We understand that your circumstances may change throughout the year. Things may occur which would prevent you from meeting your giving goal. Conversely, you might be able to give more than anticipated. This is not a pledge but an

estimate of giving which can be changed at any time. This process will facilitate budget planning to support St. Paul and our missions in 2025.

Please join us in this opportunity. Stewardship isn't a chore but a task performed willingly with the joy of personal giving and involvement in the life of our church.

#### ANNUAL FOOD DRIVE

The Women Fellowship's Annual Food Drive will be held during the month of October.

Each year the Food Pantry provides families with the items needed to prepare a Thanksgiving dinner. The following is a list of the suggested food items: instant mashed potatoes, cranberries, gravy, cornbread mix, boxed stuffing, applesauce, biscuit mix, yams. green beans, corn, peas, pie filling.

Of course, any and all food items are gladly accepted. If you wish to have us purchase your food items, please make your check to St. Paul with a notation indicating the Food Drive. Please bring your donations to the church on Monday, Tuesday, Friday mornings or with you on Sunday mornings. There are containers located at the ramp and Narthex entrances. The goal for this year is to collect 1900 items of food.

## **OPPORTUNITIES**

## **ENDOWMENT FUND**

There is a copy of the endowment policy on the back table. You may consider making a gift to St. Paul that will support this historic congregation into perpetuity. For as little as \$1,000 you can establish a named fund that will support this ministry even after you are gone. Please contact the church office with any questions.

## **DID YOU KNOW?**

The Stewardship committee would like to mention a feature of the new tax law that could be of benefit to those who have attained age 72, who hold investments that are subject to RMDs (required minimum distributions) from IRA accounts. The account owner may direct the distribution check to an exempt charity, avoiding federal and state taxes, rather than receiving the required RMD check themselves. To be tax exempt, the distribution must be made payable directly to a qualified charity or church.

RMDs required from other investments such as 401(k) or 403(b) accounts do not qualify for this tax exemption. However, this same benefit can be obtained by transferring the desired RMD amount from these accounts to an IRA before December 31 of the year before the RMD is required.

So, for those over 72 with investment accounts, this new tax provision can be a major advantage to church members. And, this exemption is not limited to the required minimum—more can be distributed if desired.

If you have questions, you may contact Kenny Kunz, Finance/Budget Committee Chairman. For more information, a call to your tax advisor or financial institution is advised.

Pastor Andy opened the meeting with prayer:

The floor was open for comments. No comments.

The meeting agenda was reviewed. Dawn Grosse made the motion to approve the agenda. Motion seconded by Vickie Estes. Motion passed.

Maureen Heck made a motion to approve the June minutes as submitted. Seconded by Dawn Grosse. The motion carried.

## **Old Business:**

- 1. Craig Schannuth has contacted West Paving concerning repair to the parking lot. They will be submitting a bid to grade the lot for adequate drainage and resurface with asphalt.
- 2. Dale Maune is obtaining bids to complete the painting of the aluminum trim on the church possible alternative to standard scaffolding.

## **New Business:**
